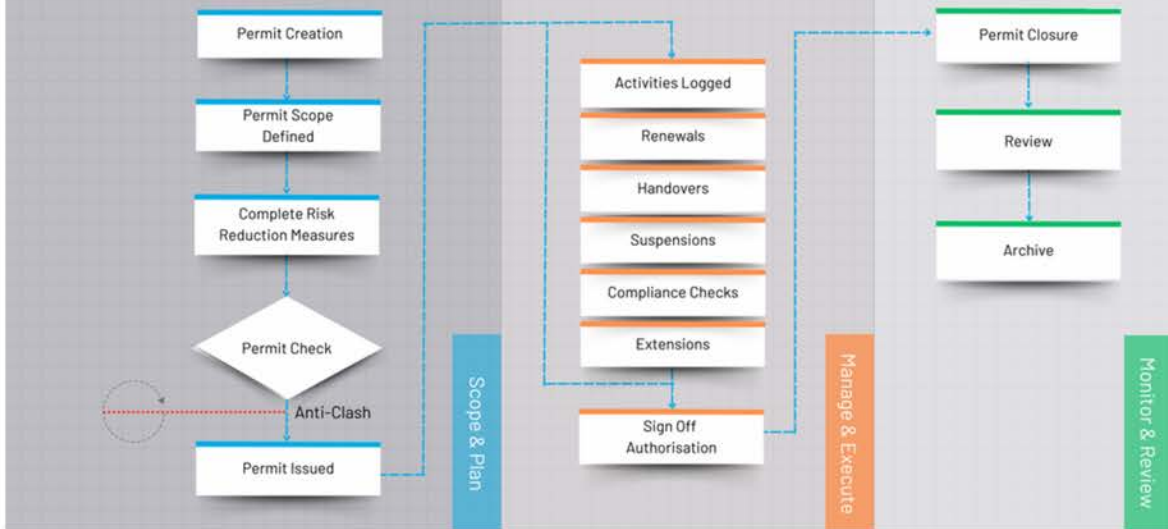

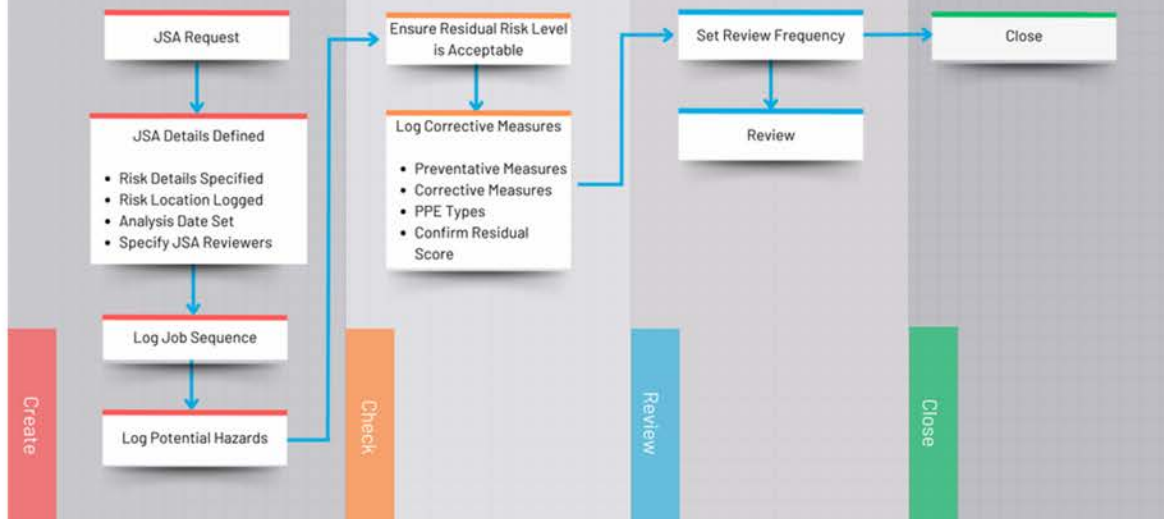

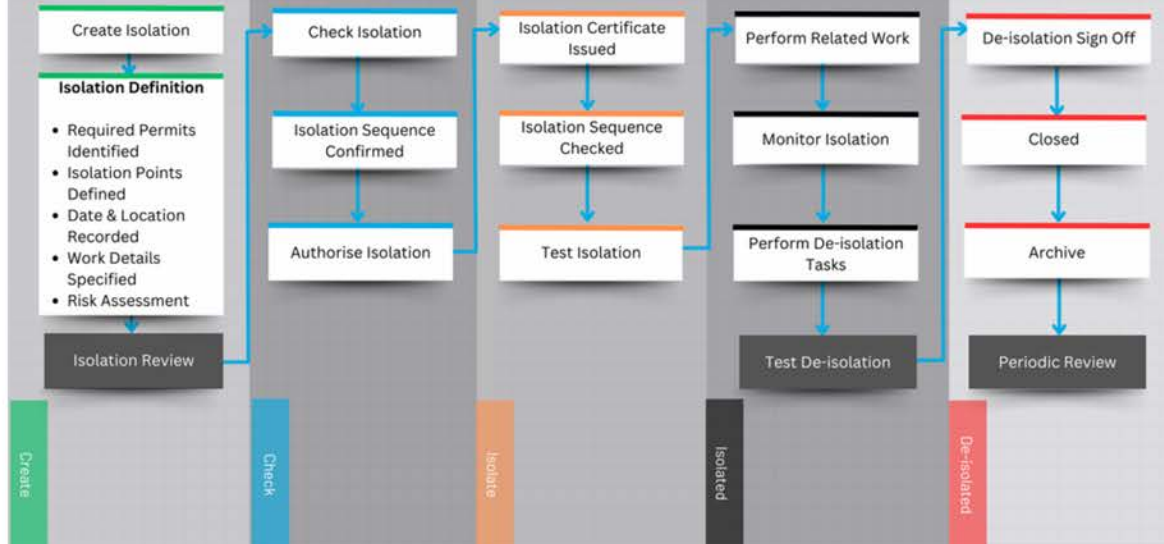
## The Typical Lifecycle of a Permit in iPermit


